### Dosage:

Preventive dose: 0.5 to 1 kg Mycofix<sup>®</sup> Plus BBSH per ton of feed.

1.5 kg **Mycofix<sup>®</sup> Plus BBSH** per ton of animal feed. The dosage can be adjusted from 1.5 to 2.5 kg **Mycofix<sup>®</sup> Plus BBSH** per ton of feed.


